They will have shown exceptional initiative, boldness and dynamism, as well as exemplary management practices.

Examples include (but are not limited to):

- Exceptionally productive business spending/investment
- Adoption of new technologies that increased productivity and capacity
- Having deep ambition to scale in the future
- Where staff have grown with the SME through its journey
- Innovation and research supported and funded, even if total capital limited
- Diversification in product or service offering, showcasing the business's agility as an SME to meet changing demand
- Demonstrated a commitment to supporting their local community

### ***Testimonial (1500 word count)***

*The entry form for SME of the Region category is simple and comprises of 1500 word max description.*

### **Question: Tell us why your company should be crowned SME of the Region.**

#### Hints and tips:

- The more information and examples you can include the more the judges can base their entry on.
- Outline specific goals the company had and how they went about to achieve them?
- Explain to us how this company have spent their capital for the greatest gains?
- Tell us about the journey of the company, particularly over the past three years
- How has the company developed their workforce?
- Tell us about innovation, creativity and original thinking; adoption of new technologies and working practices to achieve operational excellence
- Have you shown strong, sustainable commercial performance; significant growth through new channels or product introduction; capitalising on market opportunity
- Testimonials from team members/ managers/ stakeholders (see more in supporting documents)
- Summarise the lessons you have learned on your journey and how any practices you have adopted could help other SMEs

## Supporting documents

- **TIP – this is your opportunity to show examples of your project, team, project plans and give a visual of your strategy to the judges**
- **We would encourage you to upload a short video (up to 1 minute) to help support your application. This could be you speaking to camera, a testimonial from a colleague, or footage of your factory/site/a product you've worked on.**
- **We cannot guarantee that the judges will view any additional items beyond 1 A4 page/1 slide per upload.**
- **Do not include any links to external websites – these will not be viewed.**
- **Please ensure you reference your supporting documents within your entry form in the relevant areas - you can name each file to make this easier for the judges to identify.**
